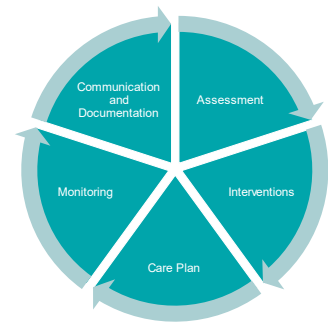
1. Status of Residents

- **New Admissions** – (level of risk/care needs e.g., fall risk, skin injury risk, elopement risk, new orders, pending lab work, etc.)
- **Discharges** – discharge paperwork, plans and teaching complete
- **Resident Change in Condition** (including review of 24-hour report)
- **Medication Changes and New Physician/Provider Orders**
- **Incidents** – Review of medical records for complete Resident-Centered Care Cycle documentation for residents with noted incidents and change in condition:
 - Falls
 - Skin Injuries
 - Wounds
 - Wandering/Elopement
 - Behaviors
 - Infections
 - Change in Condition
 - Other events

- Follow-up action from yesterday
- Follow-up action required today
